- **\$39 MM - State & Local Taxes**

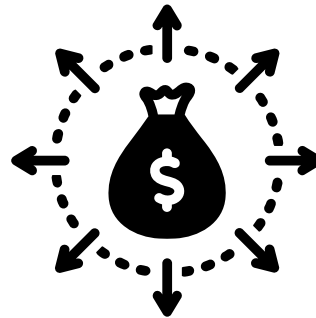

But wait, there's more!

The right to secure land for wind farms are done through a **voluntary lease or easement agreement**

- payments for recent projects have ranged as high as \$50,000 per turbine per year
